- Affidavit of Non Proprietary Character.
- \* The School Has Submitted Affidavit Which Is Not As Per Format and is only notarised. The School Is Required To Submit Affidavit Sworn Before First Class Magistrate Strictly As Per Format Given On Website [www.cbseaff.nic.in](http://www.cbseaff.nic.in).
- Land certificate.
- \* The School Has Submitted Land Certificate For Area 9267.30 Sq. Meters Stating Compactness Of Land As A Single Plot Issued By Sub-Registrar, Saloni, Raibareli, UP. But the name of school is written as S D Pandey Inter College, whereas the name of the school as per application is S D Pandey memorial Inter College. The school is required to submit a revised certificate. Also ensure that the particulars of land mentioned in the certificate is matching with the land documents.
- Land Details
- \* The land document submitted by school is not legible. The school is required to upload legible copy of the same.
- Adequacy of teaching staff
- \* 01. 21 Teachers Against 21 Sections (05 NTT, 05 PRT, 07 TGT, 08 PGT and Principal, Librarian, Wellness teacher-Counselor). But Most of the teachers are untrained. The school is required to appoint trained and qualified staff. 2. 06 Teachers On Adhoc Basis And 04 on Part Time. The School Is Required To Regularize The Staff As Per Completion of probation and should appoint regular staff. 3. The school has not submitted the details of Librarian and PTI. The school is required to appoint Librarian and PTI qualified as per norms and submit the details to Board.
- Fire Safety Certificates from concerned local authorities
- \* The School Has Submitted NOC from Fire safety department issued in 2013. The school is required to submit renewed fire safety certificate from concerned Government authority.
- School Managing Committee and no relation affidavit amongst its members
- \* The School Has Not Constituted SMC As Per Norms . The Principal Of The School Is Not Nominated As Member Secretary. The School Is Required To Re-Constitute School Managing Committee Nominating Principal As Member Secretary, and as per Rule 20 (2) of Affiliation Bye-Laws And Submit Fresh SMC List.
- Library and number of books
- \* 01 Library (30 x 25) sq feet with 3115 books. The School Has Qualified Librarian Mr. Virendra Kumar Mishra but their qualification details not given. The school is required to submit qualification details of the Librarian.
- Special Educator Teacher
- \* The School Has Not Appointed Special Educator. The School Is Required To Appoint Special Educator As Per Rule 13(11) Of Affiliation Bye-Laws Of The Board And As Mentioned In Board's Circular No. 31 Dated 25.06.2015 And Submit Qualification Details.
- Wellness Teacher
- \* It is reported that Mr Santosh Singh MA B.P.Ed, has been appointed as Wellness Teacher. Whereas the wellness teacher should be Graduate/Post Graduate In psychology. OR Post Graduate In Child Development. OR Graduate/Post Graduate with Diploma in Career Guidance and Counselling. The school is required to appoint a Wellness Teacher qualified as per norms and submit the copy of certificates to Board.
- EPF facility for staff
- \* The School Has Implemented EPF Scheme In Favor Of Society. The School Is Required To Implement EPF Scheme On School Name For All Staff Members Of School As Per Norms And Submit A Documentary Proof Along With Latest Pay Bill And Bank Challan On School Name.
- Reserve Fund as per student strength
- \* The School Has Not Submitted Copy Of Reserve Fund. The School Is Advised To Maintain The Reserve Fund As Per Strength Of The School In The Joint Names Of Principal Of The School And Managing Trustee/Member Of The Society/Trust/Company Running The School Send A Copy Of The Same.



8. The schools affiliated and running upto Senior Secondary Level will provide suitable facilities including the equipment in laboratories/workshops and games for classes XI and XII as per requirements laid down in rules.


